



## **American Nephrology Nurses Association 2023 HEALTH POLICY AGENDA**

The American Nephrology Nurses Association (ANNA) will work independently and as a member of formal or informal coalitions at the federal level to identify and respond to health policy issues that affect the practice of nephrology nurses and the individuals for whom they provide care.

### **Set Priorities for Medicare End Stage Renal Disease (ESRD) Related Issues**

1. Monitor, respond, and advocate on policies and regulations related to Advancing American Kidney Health Initiative, Executive Order July 2019.
2. Monitor and respond to proposed policies related to the Medicare ESRD Prospective Payment System (PPS) and Quality Improvement Program (QIP), and patient education programs created under the *Medicare Improvements for Patients and Providers Act* (MIPPA) (P.L. 110 275).
3. Support research to define nursing-related quality measures that are relevant to the kidney care setting and advocate for quality measures that recognize the impact of nephrology nursing. This includes collaborating with the Centers for Medicare and Medicaid Services (CMS), National Quality Forum (NQF), the American Nurses Association (ANA), and other relevant entities.
4. Monitor Medicare Payment Advisory Commission's (MedPAC) work on issues related to the Medicare ESRD program.
5. Continue involvement with various public and private quality improvement initiatives through Kidney Care Partners (KCP), the Alliance for Home Dialysis, and other entities.
6. Endorse health policy initiatives that promote organ donation, increase transplantation, and extend immunosuppressive drug coverage under Medicare for the life of the transplanted organ.
7. Advocate for legislation and funding for initiatives to promote kidney health and for education programs regarding treatment options for patients with chronic kidney disease (CKD).
8. Support quality measures that matter and promote consistency of quality programs within the Medicare ESRD benefit.
9. Monitor for opportunities to participate in technical expert panels, developed by CMS, that may impact the care of individuals with kidney disease.

## **Set Priorities for Nursing and General Health Care Issues**

1. Advocate for increased funding of the Nursing Workforce Development programs at the Health Resources and Services Administration (HRSA).
2. Advocate for increased federal funding for the National Institute of Nursing Research (NINR), the National Institute of Diabetes, Digestive and Kidney Diseases (NIDDK), and the Agency for Healthcare Research and Quality (AHRQ).
3. Advocate for legislation, funding, and other regulatory initiatives to address the nursing and nursing faculty shortage.
4. Continue to support efforts to allow advanced practice registered nurses (APRNs) to practice to the full extent of their education and training and promote their appropriate reimbursement.
5. Promote safe workplace initiatives for patients, registered nurses, and other care providers.
6. Monitor and respond to federal nursing practice issues and their effects on nephrology nursing.
7. Monitor and respond to any proposed policies which would limit nephrology nursing scope and standards of practice
8. Advocate for the role(s) of nurses in improving the health of individuals, families, and communities by addressing social determinants of health and providing effective, efficient, equitable, and accessible care for all across the care continuum, as well as identifying the system facilitators and barriers to achieving this goal.
9. Support advance institutional and legislative policies that promote Resolution on Racial Justice for Communities of Color, culture, creed, sexual orientation, ethnicity, gender, age, experience, or any aspect of identity.
10. Support policies and legislation that ensure a diverse and equitable workforce.
