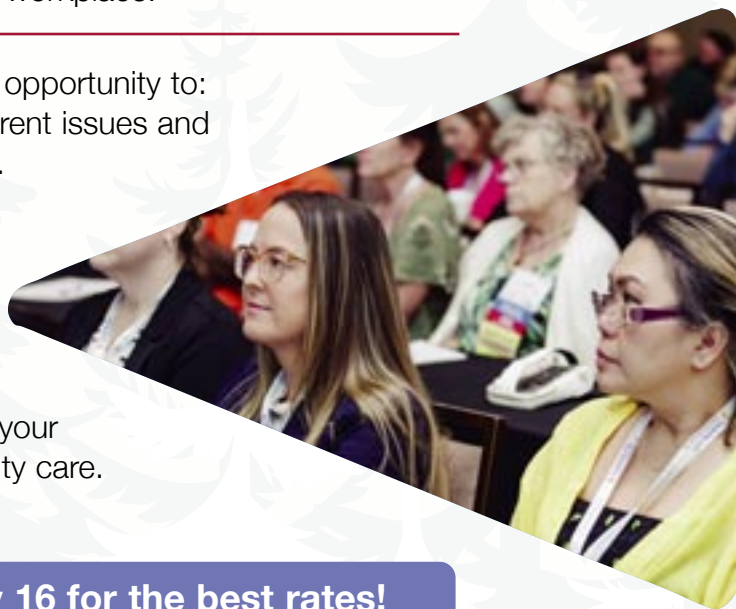

Discussions about line ownership have now expanded beyond the dialysis unit to involve the entire hospital to benefit the overall patient population.

#### **OD03 Insights into the Nutrition Management of Anemia in Chronic Kidney Disease and Dialysis, Rx**

In this session, the speaker will discuss the high prevalence of anemia in people with chronic kidney disease and the challenges of managing it in patients on dialysis, while focusing on the impact of evidence-based nutrition strategies in reducing resistance to erythropoietin-stimulating agents and resolving anemia.

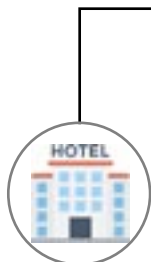
